Conditions of Entry

The committee of the West Australian Arabian Horse Association Inc (WAAHA) reserve the right to cancel, alter or combine any event/s they may deem necessary on the day.

All competitors must be a member of AHSA, WAAHA, EWA, or Perth Horse and Pony Club for insurance purposes to compete / ride on the grounds. Day membership is available for any competitor who not a member AHSA, WAAHA, EWA or PHPC.

Current Show Horse Council of WA or EWA height certificates must be presented when nominating if riding in any height classes.

Riders competing in Arabian or Derivative classes must show a valid registration certificate when nominating, must be entered in the registered owner's name and the registered owner must be a current member of AHSA.

The grounds are public open space and cannot be sealed from public access.

All entrants must sign the declaration when picking up numbers or they will NOT be allowed to compete.

All persons on horseback are required to wear a recognised standards approved helmet and boots as a condition of entry (please note new helmet standards apply as of Jan 2017, it is rider responsibility to ensure your helmet complies with this).

Dressage riders must compete at the level that they AND their horses are eligible for.

All ponies can be ridden by any age unless otherwise stated.

Tractable stallions may be ridden by a rider 18 years or over.

The judge's decision is final. Protests must be received in writing within 30 minutes of the conclusion of the event in question, with a \$100 fee attached – refund will only take place if the protest is upheld.

WAAHA reserves the right to interpret all rules & make a decision where any dispute arises. Under No circumstances is approaching the judge, judging or coaching from the side of the ring permitted. Failure to abide by these rules will lead to immediate disqualification and forfeit of entry fees.

Dogs on the ground must be kept securely on a leash at all times.

No Hay is permitted outside of horse floats or trucks – Council Regulation.

Riding on the grounds is not permitted if you are not entered, unless you pay an insurance levy and sign a disclaimer. Please take all Rubbish home with you.

The organizing committee of WAAHA inc, judges, officials, DO NOT accept liability for any accident, loss, damage, illness or injury to horses, owners, riders, spectators or any other person or property whatsoever. Entry to the grounds is at your own risk and the 'Waiver of Liability' form must be signed by all entrants prior to participation; this is a condition of our insurance.

"Open Event" shall mean a Non-Arabian event including Dressage, Hacking, Rider and Harness classes only, or otherwise agreed by the Arabian Horse Society of Australia Ltd.
